### Peddler's Faire

Memorial Day Weekend, May 23-25, 2015

Our beach town cordially invites you to participate in our annual Memorial Day Weekend Peddler's Faire. We extend our welcome to returning vendors and first timers. Please read the following information to see if this is the right place for you. *We sure do hope so!*

**WHEN:** May 23-25, 2015

*Vendors are required to participate all **three** days. Those leaving early will not be invited for the next event.*

**DAILY HOURS OF OPERATION:** 9am - 4pm

**WHERE:** Cayucos Creek Lot located at the corner of Ocean Avenue and Cayucos Creek

**COST:** \$120.00 for the first space, \$75.00 for an additional space. One additional space per vendor.

**NO REFUNDS 30 DAYS PRIOR TO THE EVENT.**

Money must be in on or before May 16, 2015 or there is a \$25 late fee.

**SPACE SIZE:** 22'x20' (frontage area of 22') Everything **MUST** fit in 22' x 20' space.

Vehicles left on-site overnight cannot block the fire lane. No loud generators. No running generators after 9pm.

**SET-UP:**

- If your motor home is over 30 ft long, you must check-in at 10am.
- You may set up and park in your space on Friday, May 22, 2015 after 12noon only.
- *No items may be sold on this day. NO EARLY BIRDS!*
- If vendors are not in their spaces by 9am on May 23, 2015 their space may be sold.

**TAKEDOWN:** Begins after 3pm Monday, May 25, 2015

All vendors must have a CALIFORNIA VENDORS RESALE LICENSE. Sales tax must be included in the price of all items. All participants are legally responsible for reporting sales tax to the State Board of Equalization. The license may be obtained, free of charge, at the State Board of Equalization office Ventura Field office: (805) 677-2700. All food concessions must contact the County of San Luis Obispo Health Dept. (805) 781-5500 and have a health permit in their possession.

All spaces **MUST** be paid for prior to the event. **EVERYTHING** you intend to sell must be listed on the application. If you would like a confirmation mailed to you, please enclose a self-addressed stamped envelope with your application and payment.

The Cayucos Chamber of Commerce personnel reserve the right to change or substitute vendor spaces for the benefit of the event and its participants. **THE CAYUCOS RESIDENTS HAVE REQUESTED THAT "NO KNIFE OR REPLICIA GUN SALES" BE MADE. YOU WILL BE ASKED TO LEAVE THE EVENT IF YOU ARE SELLING THESE ITEMS.**
